1. **DEFINITIONS**

In these Conditions of Participation and the Application/Contract, save as the context otherwise requires:

"Applicant" means the company named in Section A of the Application/Contract.

"Application" means the application by the Applicant to participate in the International Pavilion at the Exhibition, made by submitting the Application/Contract together with all necessary payments to the World Trade Fair Limited.

"Application/Contract" means the application form to which the conditions are annexed.

"Booth" means a booth in the International Pavilion at the Exhibition which the World Trade Fair Limited licenses the Participant to use for the duration of the Exhibition.

"Conditions" means these Conditions of Participation as amended by the World Trade Fair Limited from time to time

"World Trade Fair Limited" also means the authorised agent fo International pavilion of the Exhibition.

"Exhibition" means the fair or exhibition named in the Application/Contract "Hong Kong" means the Hong Kong Special Administrative Region of the People's Republic of China.

"International Pavilion" means the pavilion organised by the World Trade Fair Limited to accommodate all participants, which will be built on a specified location assigned by the fair/exhibition organiser;

"Initial Deposit" means an amount equal to 50% of the Participation Fee expressed in Section E of the Application/Contract.

"Optional Participation Expenses" means the amount payable by each Participant for additional facilities and services such as shipment of samples, extra stand facilities, traveling services and interpreters, provided by the World Trade Fair Limited at its request, which amount shall be determined by the World Trade Fair Limited.

"Participant" means the Applicant after its Application has been accepted by the World Trade Fair Limited.

"Participation Fee" means the amount payable by the Participant to the World Trade Fair Limited for the right to participate in the International Pavillon at the Exhibition, as specified in Section E of the Application/Contract.

"Products" means the goods described in Section D of the Application/Contract and which the World Trade Fair Limited agrees to accept for exhibiting at the Booth during the Exhibition.

"Project Manager" means the project manager for the International Pavilion at the Exhibition appointed by the World Trade Fair Limited.

"Publicity Material" means all and any promotional gifts, catalogues, pamphlets, advertising and publicity material whatsoever which the Participant wishes to display, distribute or use at or for the purpose of the Exhibition.

"Related Companies" in respect of the Applicant or Participant means its holding companies, subsidiaries and subsidiaries of its holding companies.

2. ACCEPTANCE

- The Applicant must be a legal entity with a valid business license or business registration certificate with substantial operations in its home
- (b) The Project Manager, on behalf of the World Trade Fair Limited, may in his absolute discretion accept or reject the Application.
- (c) The Applicant represents and warrants that none of its Related Companies, associates, or persons or companies that are effectively under its control has applied to participate in the International Pavilion at the Exhibition. World Trade Fair Limited has an absolute discretion to reject the Application or withdraw its acceptance of the Application if the Applicant shall have breached this warranty and representation

3. PAYMENT

- (a) Upon submission of its Application/Contract, the Applicant shall pay to the World Trade Fair Limited such amounts and in such manner as set out in Section E of the Application/Contract.
- (b) If the Applicant has requested for additional facilities and services in accordance with Section E of the Application/Contract, it shall further pay to the World Trade Fair Limited upon submission of its written request for such services and facilities.

CONDITIONS OF PARTICIPATION

- World Trade Fair Limited accepts no liabilities and gives no warranties or representations in respect of the quality, standard, fitness for any purpose, timing of the provision or otherwise of any of the facilities or services provided by World Trade Fair Limited at the Participant's
- (k) World Trade Fair Limited shall have discretion to deduct from the deposit paid for Optional Participation Expenses under paragraph 3(b) against any losses or expenses incurred by it by reason of the failure of the Participant to comply with the Conditions of supplying false or misleading information to World Trade Fair Limited.

SETTLEMENT OF ACCOUNTS

PARTICIPATION IN THE EXHIBITION

- (a) The Participant must be represented at the Exhibition by at least one delegate.
- (b) Any delegate nominated to represent the Participant at the Exhibition must be a senior executive of the Participant.
- (c) The Participant shall ensure that :
 - at least one delegate shall be in attendance at its Booth at all times when the Exhibition is open to visitors:

8. PUBLICITY

The agent will arrange for such publicity for the Exhibition as it shall in its absolute discretion deem fit. No Participant, delegate or other officer, representative, agent or employee of the Participant shall give or cause to be given any interview, public announcement, press statement or any other publicity whatsoever in relation to the International Pavilion at the Exhibition.

INFORMATION

During the Exhibition the Participant shall provide the agent with such information as to the business results of the Participant in the Exhibition as the Project Manager may from time to time request. Such information will not be divulged to third parties without the Participant's approval, save in relation to collective figures in respect of all or a majority of the persons or companies participating in the Exhibition.

- TERMINATION OF RIGHT TO PARTICIPATE
 (a) Without prejudice to World Trade Fair Limited's other rights and remedies, World Trade Fair Limited has the right to terminate forthwith by notice the Participants' right to participate in the International Pavilion at the Exhibition on or following the occurrence of any of the following events:
 - if the Participant or any of its Delegates, officers, representativagents or employees commits a breach of any of the Conditions
 - if the Participant, being a body corporate, enters into liquidation whether compulsorily or voluntarily or compounds with its creditors or has a receiver appointed over all or nay part of its assets or if the Participant, being a sole proprietorship or partnership, becomes or one of its members becomes bankrupt or insolvent or enters into any arrangements with its creditors;
 - iii. if the Project Manager in his absolute discretion decides that such right shall be terminated.
 - (b) The Participant's right to participate in the International Pavilion at the Exhibition shall automatically terminate in the event that all its Participants are refused entry visa or entry permit to the country or place where the Exhibition shall be held by any competent authorities.

In the event that the Participant's right to participate in the International Pavilion at the Exhibition is terminated, any expenses incurred by World Trade Fair Limited for and on behalf of the Participant prior to such termination and all other expenses reasonably incurred by World Trade Fair Limited as a consequence of such termination shall be paid on demand by the Participant to World Trade Fair Limited.

11. CANCELLATION

ANCELLATION

World Trade Fair Limited reserves the right to cancel or postpone the International Pavilion at the Exhibition at any time without incurring any liability whatsoever to the Participant if circumstances outside the control of World Trade Fair Limited (including but not limited to war, embargo, civil unrest, outbreak of disease, terrorist attacks, legal proceedings or government regulations) make it in the sole opinion of World Trade Fair Limited (which opinion shall be conclusive) impossible, impractical or undesirable for World Trade Fair Limited to participate in or hold the Exhibition. The Participant shall have no right to claim and shall not claim against the Organizer or their agents or representatives, whether for loss or damage, or return of part or all of any money paid by the Exhibitor in respect of any cancellation, reduction, shortening or Exhibitor in respect of any cancellation, reduction, shortening or extension or any other alteration made to the Exhibition made in accordance with this provision.

12. EXCLUSION OF LIABILITY

- (a) World Trade Fair Limited shall not be liable for any loss, damage or personal injury howsoever suffered by or caused to the Participant, officers, representatives, agents, employees or any third party, or its Products or other property in the course of or in relation to the Exhibition, unless such loss, damage or personal injury shall be caused by any breach by the agent or its employees of the Conditions.
- (b) World Trade Fair Limited assumes no responsibilities for any introduction or transaction made between the Participant and any third party during or as a result of the Exhibition.

 (c) The Participant shall be responsible for effecting all insurance
- coverage necessary in connection with its participation in the Hong Kong Pavilion at the Exhibition including but not limited to insurance in respect of the Products, its other property and its delegates (including travel and medical insurance)
- (d) The Participant undertakes to indemnify and at all times hereafter to keep indemnified World Trade Fair Ltd from and against all liabilities, actions, proceedings, claims, damages, costs and expenses whatsoever which it may suffer or incur by reason of or in relation to any act, omission or default by the Participant or its delegates, officers, representatives, agents and employees in the course of or in relation to the Exhibition.

13. CONFIDENTIAL INFORMATION

The Participant shall not disclose or permit to be disclosed to any person or otherwise make use of or permit to be made use of any information relating to the business or affairs of World Trade Fair Limited or other participants in the Exhibition which has been acquired by reason of the Participant's participation in Hong Kong Pavilion at the Exhibition.

14. WAIVER

No failure or delay by World Trade Fair Limited in exercising or enforcing any right or power hereunder shall operate or be construed or operated as a waiver thereof. No waiver of any breach shall be construed as a waiver of any continuing or subsequent breach

15. NOTICE

- (a) Every notice or demand shall be in writing but may be given or made by post, cable, e-mail, telex or fax.
- (b) Every notice or demand to be given by World Trade Fair Limited may be sent to the address of the Participant stated in its Application/Contract. Every notice to be given by the Participant to World Trade Fair Ltd., shall be sent to the office of World Trade Fair Ltd. at Room 1502, HK Pacific Centre, 28 Hankow Road, Hong Kong.
- (c) Every notice or demand shall be deemed to have been received in the case of a telex, e-mail or fax, at the time of despatch, and in the case of a letter three days after the posting of the same by prepaid post.

16. GENERAL

- (a) Nothing in the Application/Contract or the Conditions shall create or be deemed to create a partnership or the relationship of principal and agent or employer and employee between World Trade Fair Limited and the Participant.
